**WE ARE NOT DONE YET!** Our next Dumpster Day is **Monday, June 29th 8AM - 4PM** again at the beach parking lot. Our focus is on those of you who were not able to make the May 25th cleanup or have additional yard waste. Focus for this yard waste should be ground fuel (pine needles and cones, dead broken tree limbs...) along with making sure your manzanita bushes are no taller than mid-thigh, have ground clearance, and are not touching other bushes.

## FIRE HYDRANT PAINTING

Our community has 49 fire hydrants that are badly faded and will be difficult for emergency crews to locate during a large fire. Part of maintaining our **FIREWISE CERTIFICATION** is to maintain our hydrants.



We have new paint provided by Tahoe City PUD and they will be demonstrating how to safely paint the hydrants. This will be on **Thursday, June 25th at 110 Tahoma Ave.** 9AM

Debra Szidon is organizing this demonstration as well as gathering volunteers for the two day community hydrant painting on **July 11, 12** (1st coat of paint on the 11th, 2nd coat on the 12th)

**IMPORTANT:** JUNE 9TH at 1am on Tahoma Avenue, the Fire Department was called out as the residents smelled smoke. After searching the home, the Fire Department determined that the smoke had come from a neighboring property that had a bonfire in their backyard.

**REMINDER:** As of January 1, 2020, charcoal bbq's, bonfires, wood burning fire pits are banned at short term rentals. Please be mindful that this is another high fire danger year!
